Terms and Conditions 2011

1. All vending spaces are sold on a first come, first serve basis. Vendors must be approved by the Tucson Police Foundation (TPF) Director in charge of the event.
2. Vending space locations will be assigned by the vending coordinator and approved by the event director.
3. Load in and out times are determined by the event coordinator and will be provided to the vendor 15 days in advance of the event.
4. THE EVENT WILL BE HELD RAIN OR SHINE.
5. **Vendor is required to carry general liability insurance that will cover the event sponsors and the City of Tucson. Vendor is required to have their City of Tucson business license available for inspection at their vendor space. Additionally, a Food Vendor must have the proper Health Permit available for inspection at their vendor space.**
6. The Tucson Police Foundation (TPF), the Tucson Police Department (TPD) and the City of Tucson (COT) and its members are not responsible for any loss or damage you may incur.
7. Vending spaces may not be transferred, reassigned, split or shared without permission from the Event Coordinator. If a vending space is shared without permission, an additional space charge will be collected from the assigned Vendor.
8. The Event Director reserves the right to refuse rental space to any Vendor for any reason other than race, creed, national origin, sex, sexual preference, physical handicap or any other reason by law.
9. Vendor assumes all risks of any loss, injury, or damages. By signing this contract the Vendor assumes all risks and agrees to all stated Terms and Conditions of this contract. The Vendor holds harmless all of the following from any claims for such loss, damages, injuries or an claim in reference to or associated with the event: the Event Director who represents the Tucson Police Foundation, the Tucson Police Department, the City of Tucson Parks & Recreation Department, and the City of Tucson and all of its employees, shareholders, or any other agents associated with the event.
10. Vendor will not promote, display, possess or sell any product or merchandise that violates any Federal, State, or Local laws and ordinances regarding the sales of specialty items or trademark logos. The Vendor may not display or possess anything that may contain nude photos, juvenile pornography, or any racial, sexually offensive items or items shocking to the conscience.
11. Vendor is responsible for discarding their own trash into the supplied trash cans and receptacles. Vendors who fail to do so will be invoiced a \$100 dollar cleaning fee. If the fee is not paid within 30 days, the Vendor will be prevented from participating at future events.
12. Refunds may be provided at the discretion of the Event Director.
13. Vendor is responsible for all rental equipment used in their vending space. Any damages or loss caused by the Vendor will be the responsibility of the Vendor to resolve.
14. The undersigned Vendor agrees and understands that all applicable state and local taxes will be collected and sent by the Vendor to the proper government agencies. All Vendors **shall** have proper licenses and permits to conduct business. However the \$60 Parks & Recreation fee has been incorporated into the cost of the space.
15. Security will be provided by the Tucson Police Foundation. The Tucson Police Foundation is not responsible for damaged or missing items. It is the Vendors responsibility to double check and be sure all Vendor items are secured during the event and properly accounted for at event close.
16. If you sell cars, motorcycles, RV's, or boat trailers you must have an off-premise display and sale licensed from the State of Arizona, in order to sell these items at the event. Written permission must be obtained from the Event Director before this can take place.
17. Vendors shall comply with all Fire, Safety, Health, and Criminal Codes.
18. **BOOTH AND BULK SPACE DOES NOT INCLUDE:** exhibitor space cleaning, unpacking, repacking of exhibit material, special rigging and equipment service, storage of exhibitor material prior to set up, during the show or after breakdown, electricity/telephone/internet service, or specialized equipment such as forklifts etc.
